Keith L. Seat is a full-time mediator, facilitator and arbitrator with extensive experience mediating commercial disputes and a strong telecommunications/technology background.

He is an adjunct professor of alternative dispute resolution at the University of Maryland School of Law, and frequently trains and speaks on mediation.

He joined MBB in February 2007 as a Founding Member. He is

one of the editors for the World Mediation News, a monthly MBB newsletter that features links to the latest news about mediation and peacekeeping categorized by region. He also prepares a general mediation newsletter and is the mediation news editor of Mediate.com.

Mr. Seat was formerly the General Counsel of the Antitrust,

Business Rights and Competition Subcommittee of the United States Senate Judiciary Committee, where he played a significant role in the enactment of the Telecommunications Act of 1996; was senior in-house counsel at a major telecommunications firm; and previously practiced law for many years as a litigator at Howrey LLP, following a federal clerkship.

Mr. Seat was trained in mediation at the Straus Institute for Dispute Resolution at the Pepperdine University School of Law. He received additional mediation training from the Harvard Negotiation Insight Initiative at Harvard Law School and the Center for Dispute Settlement. He holds a J.D. from the University of Missouri School of Law.

Among other professional affiliations, Mr. Seat is a fellow of the International Academy of Mediators and a board member of the Global Negotiation Insight Institute.

MBB LA Chapter Meets with Deanna Armbruster from NSWAS

On October 11, eight MBB members of the Los Angeles Chapter, met with Deanna Armbruster of Neve Shalom Wahat el Salaam for dialogue (NSWAS). We met in the Public Dialogue room at the exhibition “Foreign Exchanges: Galileo”, by artist and MBB FM, Dorit Cypis, which addresses identity and cultural difference. As this room has been arranged with circles of distinctly unique chairs, each person chose a chair to occupy, as a different way of defining themselves.

Deanna described at length the history and present state of NSWAS, its complexity and changing relations with the po-

litical climate in Israel. Dialogue became deeply interesting when we began to see how traditional rational and linear thinking about identity and prejudice breaks down when it is experienced in day-to-day reality.

This distinction is a core principal of discussions on identity and especially for MBB members working in other cultures, it is important to see that identity both has symbolic meaning and simultaneously is defined by experience.

MBB LA and Deanna agreed to continue discussing possible ways of working with NSWAS in the future.

Neve Shalom/Wahat al-Salam (“Oasis of Peace”)

Neve Shalom/Wahat al-Salam (“Oasis of Peace” in Hebrew and Arabic) is the only community in Israel where Jews and Palestinians, have made a determined choice to live, work and educate their children together in the spirit of equality.

The village was founded in 1972 by Father Bruno Hussar, born Jewish and converted to Catholicism, he envisioned a community where Jews, Muslims and Christians would set an example for the region by creating an environment of trust, understanding and mutual respect. Located midway between Tel Aviv and Jerusalem, the “Oasis of Peace” consists of 55 families, equal numbers of Jewish and Palestinian families who are all citizens of the State, with another 500 families on a waiting list.

Educational projects in the community allow it to exert a positive influence on the Israeli-Palestinian conflict extending beyond its own borders. These include its School for Peace, the first ever bilingual, binational, multicultural Primary School and the Pluralistic Spiritual Center.

School for Peace: Founded in 1979, more than 40,000 youth and adults have participated in facilitated conflict management workshops addressing issues such as equality, rights, justice, identity, and resources. A leader in dialogue and conflict management, activities include university courses, programs for women, training programs in facilitation and workshops for teenagers.

In recent years, programs supported by the United States Agency for International Development and the European Union have focused on creating a cadre of leaders in civil society and developing negotiation frameworks for future peace agreements.

The Primary School: Founded in 1983, the Primary School (K-6) is the first bilingual, binational, multicultural Jewish-Arab school in the region. Offering classes to in both Hebrew

and Arabic while recognizing issues of national identities, the school draws 90% of its students from communities surrounding the village.

Special activities include a state of the art Language Laboratory, a Multi-Media Resource Center, an Archaeology Project where children are uncovering a Byzantine floor, a Zoo Lab for interactions with animals and the Ecology Project to teach children about the impact environmental issues. Other bilingual schools in the region are based on the model at Neve Shalom/Wahat al-Salam.

The Pluralistic Spiritual Center: In memory of Father Bruno Hussar, the center coordinates seminars and lectures on spiritual and ethical values. Programs include Dirasat, three seminars on Feminism in Islam, the Image of Jesus in Hebrew Literature and A Christian Palestinian Reading of the Old Testament.

Another program, Mediation in a Multicultural Context is developing a topology of mediation in a multicultural society, aiming to publish a curriculum based on pilot training of mediators and mediator-trainers, focusing on the role and process of mediation between the Jewish and Arab-Palestinian society in this context.

A program for youth, “Massar Masa” brought together young people to discover the stories of their shared homeland and rediscover hope in the possibility of living together in peace.

Awards: The village has been nominated five times for the Nobel Peace Prize and awarded several prestigious peace prizes from organizations in Japan, Italy, Germany, the United Kingdom, Israel, and the United States.

Member Dues

Mediator Member dues are a minimum of US \$1 per day payable annually or quarterly. Members are encouraged to contribute an additional amount if they have the ability to do so. Excess dues are utilized to sponsor members who otherwise would not be able to participate. A member has the option of designating a specific individual to be sponsored by the excess dues; otherwise MBB allocates additional contributions to those seeking financial support. For example, some of our members in Africa and South America are sponsored in this manner. The ability to sponsor participation is limited to the amount of excess contribution pool.

Each member is assigned a quarterly renewal date based upon the join date. Due statements are e-mailed February 15, May 15, August 15 and November 15 with due dates 6 weeks later, with quarterly participants paying each time. For administrative purposes, it has been determined this is the fairest, simplest and efficient manner. Please note that members have the option of paying online via PayPal, which is slightly higher as it includes the processing fee. Fees can also be paid by a check made payable to Mediators Beyond Borders to be mailed to the Pittsburgh headquarters.

Citizen Supporters make a minimum contribution of 10 cents per day – US \$36.50. Citizen renewal date is individual based upon the join date of each supporter. **Student membership** period renews Oct. 1. The dues are US \$18.25 per year.

Purpose of Membership Dues

Membership dues do not fund any projects or initiatives. They are solely used to support the administration of the office, and are used for salaries of staff, interns and expenses for website, office supplies and insurance.

Overhead

Currently all administrative expenses and overhead are provided from membership dues and supporter donations. Robert A. Creo, MBB Secretary-Treasurer, Pittsburgh, Pennsylvania, USA and Sandi DiMola, MBB Director, Pittsburgh, Pennsylvania, USA, donate office space for MBB. All directors, officers and mediators serve as volunteers and do not receive any compensation for their administrative or professional services. Directors and members expend their personal funds to participate in conferences and activities on behalf of MBB. Neither the officers nor directors receive any reimbursement for travel or other expenses.
