#### **Israel: Mediation Gains Momentum**

Mediation in Israel has developed momentum over the last year, since the Justice Minister approved implementation of a mandatory court-annexed mediation program to begin in March 2008. The pilot program in the magistrate courts of three cities will require parties in civil cases above a certain size to participate in a mediation session prior to going to trial. The court is proceeding carefully with the mandatory program, and is seeking to learn from mediation programs in courts around the world, noting that there are substantial differences in approach between common law jurisdictions (such as the U.S. and U.K.) and civil law jurisdictions (such as Continental Europe).

#### **Progress on MBB's First International Effort; Need in Liberia**

*Editors' Note: As anticipated in the last newsletter, an MBB team including Bob Creo, Ingrid Lundberg, Prabha Sankaranarayan and Harriett Nettles did travel to Ghana in late November to explore possibilities for the Buduburam Liberian Refugee Settlement project and to work on dispute resolution capacity building. Harriett reports that the MBB team's trip was very successful -- they trained over 60 mediators in a week's time and were able to make a brief trip to visit the Slave Coast historic sites to deepen their understanding of the historical interconnection of Ghana and the United States. In January, Harriett was able to return to Buduburam for one day and found that the MBB trainees have found opportunities to utilize their new mediation skills, and that there are more potential mediators clamoring for a second training. Bob Creo is planning to return in the Spring to continue the work. Harriett then continued on to Liberia for ten days to complete a needs assessment for a proposal for an extensive MBB project in Liberia. Harriett writes:*

Two recent trips to Liberia to explore possibilities for Mediators Beyond Borders have left me with as many questions as answers. As I sat in on the hearings of Liberia's Truth and Reconciliation Commission in January, I sensed the strength of a force I can only describe as demonic or evil. At the same time, I was aware of the incredible effort and personal sacrifice of Ellen Johnson-Sirleaf, the first elected female head of state on the African continent, and her cabinet, who have returned to rebuild their country from total devastation. The worst and the best of humanity juxtaposed.

The story that moved me the most was not the most gruesome I heard at the Commission that day. The prior speaker's hands and ears had been cut off due to his tribal affiliation by a rebel wielding a machete. He has since seen his attacker driving a bus in Monrovia. I listened, dumbstruck by the great challenge of any sort of healing or forgiveness that confronts the majority of Liberians. And they are the lucky ones, who managed to survive fourteen years of civil conflict as the rest of the world did what we typically do in the face of gross human tragedy – nothing.

Then a young girl began to speak quietly of watching her parents murdered. She was taken in by a kind old lady who was also killed. Orphaned and alone, she was then taken in by a man. Those present began to snicker and the Commissioners called for silence. It was only as she began to speak of the present that she began to sob. He beats me, she spoke through her tears. Can you help me? The Commissioners thanked her for her testimony and called for the next speaker.

The prevalence of domestic violence is estimated at over 80% in post-conflict Liberia. It seems that people have lost the ability to deal with life's conflicts without resorting to violence. People shake their heads and say, Liberians were such a peaceful people before the war . . . how did this happen? The Truth and Reconciliation Commissioners could do nothing for the girl. Indeed, there is

One ex-commander admits responsibility for the deaths of over 20,000 people and ritualistically eating the hearts of children before going into battle wearing only his combat boots. Since then, he has had a religious transformation and lives openly in Ghana.

The Commission may not be able to do anything, but we can. The Association of Female Lawyers in Liberia has requested training for their legal staff in mediating cases of domestic violence and child support, in part to conserve time for more egregious cases that must go to trial. They would like information on programs that have been successful in this kind of work in the U.S.
